Anne-Laure TISSUT is a Professor of American Literature at the University of Rouen, France. Her research focuses on contemporary American literature, aesthetics, exchanges between forms and media as well as on translation. She also translates American and English fiction and poetry into French (Percival Everett, Nick Flynn, Amy Hollowell, Laird Hunt, Jerome Rothenberg, Adam Thirlwell, Steve Tomasula) and takes part in collective translations from French into American English.

Dan BEACHY-QUICK is a poet and essayist, author most recently of a collection of essays, fragments, and poems, *Of Silence & Song* (Milkweed Editions, 2017). His work has been supported by the Lannan and Guggenheim Foundations, and he teaches in the MFA Creative Writing Program at Colorado State University.

Her work has appeared in the Financial Times, the Times Literary Supplement, the London Review of Books blog, and the Los Angeles Review of Books.

Pierre-Antoine PELLERIN is a lecturer in English studies at the Université Jean Moulin – Lyon 3, where he teaches American literature and translation. His PhD focused on the experience and representation of masculinity in Jack Kerouac's autobiographical cycle. He has published several articles on Beat Generation authors, most recently "Masculinité, immaturité et devenir-enfant dans l'œuvre de Jack Kerouac," *Leaves* 2 (2016). His other research interests include gender studies ("Reading, Writing and the

'Straight White Male': What Masculinity Studies Does to Literary Analysis," *Angles* 3 (July 2016)) and ecocriticism ("Jack Kerouac's Ecopoetics in The *Dharma Bums* and *Desolation Angels*: Domesticity, Wilderness and Masculine Fantasies of Animality," *Transatlantica* 2 / 2011).

Florian BEAUVALLET is completing a thesis on the work of the British novelist Adam Thirlwell, entitled 'Toward an aesthetic of flippancy: the art of the novel of Adam Thirlwell' (under the direction of Anne-Laure Tissut at the University of Rouen) which offers an inaugural critical study of one of the striking voices of contemporary British fiction. His publications include 'Le passé est imprévisible' and 'L'imaginaire du montage' (published on « L'atelier des savoirs »). He also teaches literature and translation at the University of Rouen.

Sophie CHAPUIS is Associate Professor at the University Jean Monnet, Saint-Etienne, France where she teaches American literature. She received her PhD in American literature from the University of the Sorbonne Nouvelle – Paris 3 in 2012. Her dissertation surveyed the complete works of American novelist and short story writer Rick Moody, focusing more specifically on the notions of accident and catastrophe. She has since then explored various aspects of Moody's fiction and published articles about masculinity, illness, and domesticity.
